

# PRODUCT USE GUIDE FOR COMBAT ALCORINSE CB127

### **Product Description**

Combat Alcorinse is designed as both a post wash hand disinfectant in food production and serving areas where very high standards of hand hygiene are required, and as a quick drying surface sanitizer, applied by either spray or swab. Complies with the European Suspension Test BSEN1276 and is effective against pseudomonas aeruginosa, escherichia coli, staphylococcus aureus and enterococcus hirae with a contact time 30 seconds.

# **Directions for Use**

- Hand Care the product is formulated to prevent skin drying, it rapidly kills bacteria. Dispense directly onto hands from a suitable dispenser after washing with a bactericidal hand cleaner.
- Use the product every time the hands are washed and at every re-entry into the high risk food process area. Booster doses on the hands may be applied between washes.
- Surface Sanitization. Apply neat via clean cloth or paper wipe and leave to dry. Requires no rinsing or further wiping.

#### **Product Features**

- Tested under BSEN1276 and found to kill 99.999% of bacteria within 30 seconds and is effective against Pseudomonas aeruginosa, Staphylococcus aureus, Enterococcus hirae and Escherichia Coli.
- Contains no added fragrance
- Non tainting to food.

# **Direction for Use**

- Use the product neat.
- Apply by spraying onto previously cleaned surfaces.
- Allow to air dry.

#### Storage

- Store in cool conditions away from direct sources of heat
- Avoid extremes of temperature
- Do not allow to freeze
- Ensure the cap is tightly fitted after use
- Keep out of reach of children

#### **Shelf Life**

- Shelf life 24 months, if stored as recommended.
- Use within 6 months of opening.

# **Environmental**

- Do not allow large quantities of neat product to enter surface waterways.
- In the event of a large spillage, contact the local water authority or Environment Agency immediately.
- This product uses recyclable packaging. The detergents used in the formulation are biodegradable to EU guidelines under the detergents regulations (EC) No 648/2004.
- It contains no Phosphates.
- None of the components of this product are animal derived.
